Met ei Angangen Affeer (ika Mediation)?

- Angangen Affeer (ika Mediation) e aora ngonuk **tufichin om kopwe poraus** ngeni noumw iwe landlord won etipeewin an epwe wor kokkootun nikinikin kameetiwi (ika payment plan), ika epwe pwan anisuk aami oupwe tongeni chufengen ne aplae ngeni aninnisin rent, me mi pwan fen tongeni anisuk om kopwe tingor epwe wor ekkesiiwin non om iwe etipeewin rent (ika lease) (ika pwe ewe landlord e tipeew ngeni), ren om kesapw toou.
- Angangen Affeer (ika Mediation) esap ew kinikinini non angangen kapung iwe **kese pwan meeni om kopwe feeri**. Ese wor osukosukan, ese pwapwaano, iwe en ke pwisin finaata mefiom.

Met epwe tongeni fis?
